I. STRUCTURE

1. The National Preventive Mechanism unit (NPM):

The NPM unit plays a preventative role differing from the reactive role carried out by the rest of the Ombudsman units.

The NPM unit is composed of:

- 1 Unit chief.
- 5 Technical staff.
- 2 Administrative personnel.
- 2 Coordinators (Chief of the Area of Security and Justice and Chief of the Area of Migration and Equality).
- Specialized technical staff from other areas of the Ombudsman Institution that may play a role in the visits.
- External technical personnel (psychiatrists, psychologists, forensic doctors...).

2. The Advisory Council:

It is the coordinating technical and legal body of the NPM.

The Advisory Council meets twice a year.

Tasks:

- a) propose visits;
- b) make proposals for improving the methodology of visits and follow-up visits;
- c) compile reports concerning legislation;
- d) propose training programs and seminars on prevention of torture;
- e) follow-up on NPM and SPT reports.

Composition (11 members)

- a) Headed by the Ombudsman
- b) The 2 deputies of the Ombudsman
- c) 1 member appointed on a proposal by the General Council of Spanish Lawyers
- d) 1 member nominated by the Spanish Medical Colleges Organization
- e) 1 member nominated by the General Council of the Official Psychologists Associations
- f) 5 members appointed among candidates submitted through an open call for nominations, in personal capacity or in representation of a civil society organization or association. Spanish SPT member, Emilio Ginés, is one of them.

3. Budget

Amounts to 744,402.19 euros. Detailed in Annex 1.

II. COMPETENCIES

- 1. Regulatory reforms proposed:
- 1.1. Amend article 174 of the Criminal Code, to adapt the definition of the crime of torture to meet the provisions of the United Nations Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, regarding:
 - a) Capacity to prosecute not merely civil servants but people who work in the center.
 - b) That the punishment is in accordance with paragraph 2 of article 4 of the United Nations Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.

Article 4

- 1. Each State Party shall ensure that all acts of torture are offences under its criminal law. The same shall apply to an attempt to commit torture and to an act by any person which constitutes complicity or participation in torture. 2. Each State Party shall make these offences punishable by appropriate penalties which take into account their grave nature.
- c) Obligation of the State Party to establish punishments appropriate to the degree of severity of the offense.

1.2. Amend article 520 of Criminal Procedure Law (rights of detainees), to:

- a) Reduce the 8-hour time limit in which the right to legal assistance must be effective (Accepted).
- b) Enable the detainee to be interviewed confidentially with his or her lawyer (Accepted).
- c) Include detainee's right to request habeas corpus (Accepted).
- d) Provide information regarding rights (Accepted).

1.3. Amend incommunicado detention:

- a) Prohibit its application to minors (Accepted for minors under 16).
- b) Allow detainees to be interviewed, in private, with their lawyers (According to the case. Accepted).
- c) Continually record images and sound (Gradually accepted. Systems are being installed).
- d) Daily supervision of the incommunicado detainee by forensic doctors (Accepted).
- e) Assign an independent doctor for an independent examination (No answer yet).
- f) Communicate the detention to the detainee's family (According to the case. Accepted).

These Recommendations have been introduced in the Organic Law 13/2015 October 5th, Criminal Procedure Act Modification.

1.4. Full regulation of involuntary civilian admissions to healthcare facilities.

2. Unannounced visits to facilities of deprivation of liberty

- a) To any center, including privately owned ones (for example, healthcare establishments).
- b) Carry out personal interviews (civil servants, employees or persons deprived of liberty).
- c) Study of cases and documentation.

Visits to facilities can include any technical means of support (for example, any means of transportation).

Since the beginning of its mandate, the NPM has visited 543 places of deprivation of liberty, detailed in **Annex 2**.

III.- METHODOLOGY

1. Tasks

- 1. Carry out unannounced visits to places of deprivation of liberty.
 - Compile reports on the visits.
 - Send Recommendations to authorities.
- 2. Maintain dialogue with the Public Administration for the execution of its Recommendations.
 - Formulate proposals for regulatory reforms.
 - Supervise the execution of Recommendations.
 - Compile an Annual Report.
 - Maintain contact with other NPM and SPT to exchange experiences and reinforce effectiveness.
 - Maintain contact with Civil Society.

2. Phases

2.1. Preparatory Phase

Selection criteria for facilities to be visited.

- a) Time passed since the last visit.
- b) Recently introduced regulatory amendments.
- c) Following up the results.
- d) News in media outlets.
- e) Information from civil society organizations.
- f) Supervision of all national territory.

In order to prepare the visit a dossier is compiled including information on the type of center, the activity, organizational structure and regulations.

2.2. The visit

Criteria for compiling the team:

- a) Objective of the visit.
- b) Knowledge on the establishment and its problems.
- c) Size of the establishment and number of detained persons.
- d) Commission of external technical experts (doctors, psychiatrists, psychologists, etc.).
- e) Participation of members of the NPM Advisory Council and Regional Autonomous Commissioners.

The NPM interviews the manager of the center to learn about the situation of those deprived of liberty, as well as to inform the manager about the actions that will be carried out and to request all documentation that will be examined.

In addition, a visit is carried out in the facilities of the center that can last for several hours or days. Staff examines cells or rooms, sitting rooms, hallways, nursing facilities, kitchen, offices for officials, health facilities, toilets, sports and leisure facilities, workshops, etc., as well as all documentation in the center and security and video surveillance systems.

Persons deprived of liberty and the center's personnel can have confidential interviews with the NPM. At the end of the visit, the manager is informed of good practices and deficiencies detected.

2.3. Results of the visit

Once the visit is concluded, the Resolutions and Conclusions addressed to the authorities are recorded.

2.4. Publication

All activity is reported in the published annual reports and on the Ombudsman webpage. The webpage publishes the facilities visited, the composition of the team, the methodology as well as conclusions, Resolutions sent to the authorities and responses received. The webpage offers geographical and chronological information regarding all facilities visited.

The annual report details the conclusions of each visit and adds photographs of the centers visited.

IV. THE NPM IN 2015

1. Visits by the NPM to centers of deprivation of liberty;

In 2015, 62 visits have been carried out to places of deprivation of liberty. Ombudsman has participated in 7 visits.

Members of the NPM Advisory Council have participated in 11 visits and members of the Regional Autonomous Parliamentary Commissioners have participated in 8.

Details regarding these visits can be found in Annex 3.

External technical personnel, experts in medicine, forensic medicine, psychiatry and psychology have participated in 17 visits. They visited:

- a) 5 Juvenile Centers for the Fulfillment of Judicial Measures
- b) 9 Penitentiary Centers
- c) 2 Healthcare Centers and
- d) 1 Immigrant Detention Center

34 visits were follow-up visits in order to verify compliance with the recommendations made.

10 visits were made to penitentiary centers, in order to obtain information regarding the implementation of mechanical restraints, with the aim to carry out a study regarding this issue.

2. Resolutions and ex officio investigations during 2015:

The following **Resolutions** have been put forth:

- a) 58 Recommendations
- b) 224 Suggestions
- c) 2 Reminders of Legal Duties

106 ex officio cases have been initiated

3. Institutional Activities, training and outreach (These activities are detailed in Annex 4)

In 2015 the NPM has participated in several forums, those to highlight are:

- a) Seminars of the 30th Anniversary of the United Nations Convention against Torture carried out by the General Council of Spanish Lawyers (January 10th 2015);
- b) The 1st Training on Immigrant Detention Centers organized by the National Police Force's Central Unit on Expulsions and Repatriation (April 15th 2015);
- c) "ENO (European Network of Ombudsman) investigators' meeting on forced returns";
- d) Colloquium "Monitoring repatriation flights" of the "10th National Seminar of the European Network of Ombudsman", organized by the Polish Ombudsman and the European Ombudsman;
- e) "IOI Workshop for NPM Implementing a Preventive Mandate", organized by the Ombudsman of Latvia and the International Ombudsman Institution (June 17th 19th 2015);
- f) Conference given by the Academy of Civil Guard officers in San Lorenzo del Escorial, on the role of the NPM (February 18th 2015).

The NPM Unit has collaborated with National Preventive Mechanisms against Torture (NPM) and human rights institutions in other countries, holding working meetings to explain the methodology of the Spanish NPM and its practices during visits to places of deprivation of liberty, such as

- a) with the Moroccan Inter-ministerial Delegation on Human Rights;
- b) with NPM representatives from Paraguay;
- c) with technical staff from the Mozambique Ombudsman;
- d) with a delegation from the Ombudsman of the Czech Republic;
- e) with the Human Rights Commission of the Philippines.

Lastly, Technical Chief and NPM coordinators have participated in Ankara on the European Union Project "Support to Establishment of Ombudsman Institution in Turkey" (June 2014 – March 2016).
